
INFORMATION ON THE PROCESSING OF PERSONAL DATA

Dear Supplier,

Kronospan Italia S.r.l., based in San Vito al Tagliamento, via Bordano 10, tel. 0434.844211, as entity responsible for the processing of personal data (hereinafter "Data Controller"), issues this information to the party concerned ("Data Subject") in compliance with European and Italian legislation regarding the protection of personal data.

Purpose and legal basis of the processing

The Data Controller processes the Supplier's personal data for the purpose of adopting pre-contractual measures, fulfilling contractual and regulatory obligations related to the business relationship, as well as pursuing the legitimate interest to carry out qualification and/or monitoring processes, to manage possible litigation and, in general, to correctly manage the commercial relationship.

The legal basis for the processing is the pursuit of the aforementioned purposes.

Period of retention of personal data

The Data Controller will process the Supplier's data for the duration of the commercial relationship and, subsequently, for the fulfilment of any obligations connected with or deriving from the establishment of the same, for the period prescribed by the law and according to the limitation period of the rights arising from the business relationship, without prejudice to further retention for the time necessary for the settlement (however reached) of any disputes that may have arisen.

Nature of the data provision and consequences of refusal

The provision of data is necessary, and therefore any refusal to provide them in whole or in part may make it impossible for the Data Controller to pursue the aforementioned purposes.

Categories of recipients

The Data Controller will not disclose the data but intends to communicate them to internal figures authorised to process that data according to their respective duties, as well as to Group companies, credit institutions, business associations and/or organisations, professionals or service companies and public and private organisations, also following inspections and checks.

These recipients, if they process data on behalf of the Data Controller, will be appointed as data controllers with a specific contract or other legal act.

Data transfer to a third country and/or an international organisation

Personal data will not be transferred to non-European countries or to international organisations.

Rights of the Data Subjects

Data Subjects have the right to ask the Data Controller to access their personal data and to rectify them if inaccurate, to cancel them or limit their processing if the right conditions are met, to oppose their processing for legitimate interests pursued by the Data Controller, and to obtain the portability of personally supplied data only if subject to automated processing based on consent or a contract.

The Data Subjects also have the right to revoke their consent given for the relevant processing purposes, without prejudice to the lawfulness of the processing carried out until the time of revocation.
